## 1. New Publication

This Nuclear Policy Paper pictures the debate over the future of tactical nuclear weapons in Europe within a broad context of political and military-technological issues. Exploring problems in the NATO-Russia "correlation of forces" it points out that chances of cooperation may be found far from classical arms control solutions.

## 2. Russian TNW stockpiles - new numbers

Do we know how many non-strategic warheads Russia actually has? The findings of this paper challenge the assumption that Russia holds a large supremacy in non-strategic warheads: if the US and NATO wish to negotiate non-strategic nuclear reductions with Russia, this paper suggests that they will need to acknowledge the diverse elements and geographically dispersed tasks of Russia's stockpile, and find a new way of prompting Russia to reassess its security needs.

#### 3. Central European views on TNW

Using the DDPR as the point of departure, the PISM report is meant to provide an analytical glimpse into the future—the next decade of the functioning of NATO's deterrence posture, as seen from Central Europe. It concentrates on the regional perceptions of the security environment and threats, the assessments of the credibility of NATO's policy, and the way forward. Taking into account the perspective of a turbulent decade in which the viability of NATO's defence and deterrence posture will be subjected to external and internal pressures, understanding the concerns and viewpoints of Central Europeans would help in charting the right course for the Alliance.

#### 4. US boots on the ground in Poland

A group of up to 10 American troops became the first ever full-time US 'boots on the ground' in Poland. Washington already rotates a Patriot missile battery through Poland. A statement issued by the Russian defence ministry said Moscow would "take into account the American-Polish plans and carry out its own armed forces development projects" adding it "believed that different decisions would be better in the interest of European security".

Meanwhile, U.S. Ambassador Stephen Mull, who recently took up his post in Warsaw confirmed that "President Obama is absolutely determined to form a missile shield base in Redzikowo in 2018". At this moment the United States are sending scientist to the Redzikowo Base to survey the buildings on the base in preparation for the 2018 Aegis Ashore Ballistic Missile Defense facility.

## 5. Debate on Nuclear Weapons in Germany intensifies

On 20 December, the German government replied to questions of the Green Party in the Bundestag on a range of arms control and disarmament issues. German government response to Green Party Parliamentary questions On the B61-12 the government repeats its position that the LEP is a national U.S. programme on which no final decision has been taken. The government states that the US has assured allies in the NPR that the LEP does not presume the results of future decisions within NATO about the requirements of nuclear deterrence and nuclear sharing. The government states that NATO's intention to propose confidence and transparency measures on TNW to Russia can support and complement efforts to include TNW in a future US-Russian arms control accord. It concedes that discussions on the mandate of the new arms control committee are continuing and pledges that it will continue to implement the coalition agreement and work towards withdrawal of TNW from Germany.
