2009 Peace Report in Berlin and Brussels

How to End Wars?

Afghanistan and Pakistan are keeping international politics on edge and an end to the fighting is not in sight. In Africa, in the Caucasus and in the Middle East, some ceasefires will probably turn out to be the calm before the next storm. Such findings necessitate the focal question of the Peace Report 2009: How can wars and violent conflicts be brought to an end – and how can they not?

The battle grounds of the recent armed conflicts are weak or failed states, and it is their societies that are being fought over. At stake are concepts of political order and the political support of the people. Military force is rarely decisive in such contests. Yet it is still widely assumed that more troops lead to more security and that wars can be ended by military superiority. The emphasis on military power often papers over the lack of a political concept. The majority of the current wars, however, cannot be brought to a lasting end without the presence of legitimate and functioning governance structures at the foundation of society.

This is the conclusion drawn by the Peace Report 2009, which the representatives of the five editing institutes presented to the Federal Press Conference in Berlin on 26 May 2009. The editors were able to discuss their results and recommendations with the chairpersons of the Bundestag's Committees on Economic Cooperation and Development Thilo Hoppe (The Greens), Defence Ulrike Merten (SPD), Foreign Policy Ruprecht Polenz (CDU) and numerous parliamentarians. A more extensive meeting took place in

the Federal Ministry for Economic Cooperation with State Secretary Erich Stather. A meeting with the German-South Asian parliamentarians' group of the Bundestag and a public event in cooperation with Women in International Security (WIIS) and the Atlantic Initiative completed the Peace Report's guest appearance in the capital.

Beyond the primary thematic area, this year's Peace Report takes soundings on the new perspectives opened up by the Obama government on integrating Russia into European security structures as well as on disarmament and arms control. In this connection it recommends, inter alia, that all nuclear weapons be withdrawn from Germany and that there be a commitment to the principle of no first use of nuclear weapons. Another chapter deals with the potential for conflict in the international financial crisis and addresses the policies of and instruments for constructive non-military conflict transformation.

IFSH contributions to the Peace Report 2009 were authored by, among others, Michael Brzoska, Hans-Georg Ehrhart, Margret Johannsen, Martin Kahl, Oliver Meier and Wolfgang Zellner. Annette Weber (SWP) contributed as guest author, while Margret Johannsen acted for the first time as IFSH's co-editor and coordinator of the project. The editors gratefully acknowledged the decade-long commitment of Reinhard Mutz, who had been part of the project from its very start, at first as Egon Bahr's right-hand man and later on until 2008 as the responsible editor for the IFSH.

In June, two events concerned themselves with the Peace Report 2009 - one in the Protestant Academy Arnoldshain, the other one hosted by the Bonn House of History, in a joint enterprise with the German Society for Foreign Policy. In July, the Peace Report is heading for Brussels and will present its main findings for discussion at the International Security Information Service (ISIS) Europe.

Publication on arms control for a conference in the Foreign Ministry

Representing Foreign Minister Steinmeier, Minister of State Gernot Erler held a speech on June 9, 2009 in Berlin on the future of arms control. Background was a reception on the occasion of the high-level meeting on "the future of conventional arms control in Europe", in which an IFSH publication with the same title was presented. Minister of State Gernot Erler said: "So I thank all of you, as government representatives from more than forty states that you accepted the invitation of the German Foreign Minister to this informal meeting on the future of conventional arms control in Europe! Alongside this meeting, IFSH - the Institute for Peace Research and Security Policy of the University of Hamburg - under the direction of Prof. Dr. Götz Neuneck and Dr. Wolfgang Zellner and PRIF - the Hessian Peace Research Institute - represented by Dr. Hans-Joachim Schmidt, together with NOMOS publishing house is releasing a heavy volume of some 500 pages - appropriate to the seriousness and importance of the subject - in German and English, on the future of conventional arms control in Europe. My thanks and my appreciation go to all who contributed to the success of the accompanying book. Scholars

and practitioners from home and abroad, with sometimes decades of experience in disarmament and arms control, illuminate the difficult process of arms control and present some significant milestones ... I am convinced that the book will promote the discussion on the future of conventional arms control in Europe." In this volume 24 experts from the United States, Russia and other European countries analyze the current armscontrol situation and put forward proposals to overcome the current deadlock.

Expert seminar on EU in conflict prevention and civil-military crisis management

An experts seminar on "The EU in conflict prevention and civil-military crisis management - the quest for effectiveness and legitimacy" took place in the Villa Abegg of the Compagnia di Sao Paolo in Turino on 25 and 26 June 2009. The seminar has been organised by the Institute for European Policy and the Instituto Affari Internationali (IAI). Experts from the German and Italian Foreign Ministries, the EU's Political and Security Political Committee, the Council Secretariat's DGE VIII, the European Parliament, and think tanks discussed on the basis of background papers on weaknesses and strengths of the CFSP/ESDP. Hans-Georg Ehrhart (Head ZEUS/IFSH) gave a comment on the discussion paper "Military and civilian ESDP missions: Ever growing and effective?" of Sammi Sandawi (Transformation Center of German Bundeswehr) and Nicolette Pirozzi (IAI).

IFAR at EU Workshop on Non-Proliferation

At the invitation of the Czech EU Presidency an EU Workshop took place on 26 June in Prague under the title of "Enhancement of the Hague Code of Conduct (HCOC) against Ballistic Missile Proliferation". Fifty participants, among them 28 delegations from signatory states as well as delegations and participation from Libva, Mexico and the Slovak Republic, discussed possible improvements to the non-proliferation regime, which is intended to prevent the further spread of missile technology. The missile tests of North Korea and Iran have shown quite forcefully that missiles have not yet become a feature of international arms control. Götz Neuneck was a German participant in this workshop. IFAR is taking part in an EU project, which, within the framework of a Joint Action of the European Union, is intended to strengthen the HCOC and to demonstrate trends in the proliferation of missile technologies and their containment. The project is coordinated in Paris by the Foundation pour la Recherche Stratégique (FRS) [Foundation for Strategic Research] with which there is collaboration.

In Ipsen, a lecturer was found, who was not merely involved for many years in a critical dialogue with the Institute and Dieter Lutz. He also spoke on a topic that is of great importance for the work of the Institute, not least for the work program on transnational risks of violence. At the heart of his lecture, Ipsen placed national capability and responsibility in the efforts to carry out multilateral defense enterprises and emphasized the necessity of further work on constitutional and international law dimensions of the term "defense".

OSCE Chairmanship Training 2009 for Kazakhstan and Lithuania

Since 2007 CORE has conducted specialised OSCE Chairmanship Training courses: In 2007 and 2008, two four-week-long OSCE-related training courses were held for a total of 15 officials from the Kazakh Ministry of Foreign Affairs, jointly commissioned by the Kazakh MFA and the German Federal Foreign Office. This year a third OSCE Chairmanship Training course for 18 officials from Lithuania and Kazakhstan was held in Vienna from 1 to 14 June 2009. The lectures were given by CORE staff together with a number of OSCE experts from Vienna, The Hague and Warsaw. The theoretical part included lessons on general OSCE issues; the OSCE human dimension; field operations and the High Commissioner on National Minorities: new threats including economic and environmental issues, as well as on specific roles and responsibilities of the OSCE Chairman-in-Office. The practical component included five days of working meetings with heads and leading representatives of delegations of OSCE participating States, senior representatives and experts of the OSCE Secretariat and other OSCE institutions. Security and Co-operation in Eurasia: **Protecting Human Rights Must Remain a Priority for the OSCE**

Seminar in Vienna on the Tasks of the OSCE Chairmanships in 2010 and 2011

In 2010 Kazakhstan will become the first member of the Commonwealth of Independent States (CIS) to assume the Chairmanship of the Organization for Security and Co-operation in Europe (OSCE). It will be succeeded by Lithuania in 2011. The Austrian Federal Ministry for European and International Affairs, together with the Austrian Defence Ministry, the Permanent Mission of the Republic of Kazakhstan to the OSCE, and the Geneva Centre for Democratic Control of the Armed Forces (DCAF), took this opportunity to hold a one-day seminar on "Future OSCE Chairmanships: Policies and Challenges". At the seminar, which took place on 9 June 2009 in the Museum of Military History, the oldest museum in Vienna, Ursel Schlichting, CORE's Editor-in-Chief of the OSCE Yearbook, presented a paper entitled "Human Dimension Challenges and Priorities in 2010/2011". In it, she strongly stressed that the protection of human rights, including minority rights, needs to remain one of the most important tasks of the OSCE. Also speaking or otherwise present at the well-attended event were Stefan Lehne from the Austrian Federal Ministry for European and International Affairs, the Head of the Kazakh Permanent Mission to the OSCE, Ambassador Kairat Abdrakhmanov, Phillip Fluri, Deputy Director of DCAF, and the Director of the Warsaw-based Office for Democratic Institutions and Human Rights (ODIHR), Ambassador Janez Lenarčič.

IFAR at three events on the future of disarmament and non-proliferation

On 2/3 June 2009, Oliver Meier took part in two meetings of the Working Group on the Future of Disarmament at the EU Institute for Security Studies in Paris. Central to the discussions was the future role of the EU in multilateral arms control. Meier held a lecture on "A New Farewell to Arms: Giving Purpose to Disarmament in the 21st Century".

At an event at the Friedrich-Ebert Foundation on 28 May 2009 in Berlin, Meier commented on the draft of a study on the role of the EU in the Nuclear Non-Proliferation Treaty that was drawn up at the Center for Security Studies (CSS) at the Technical University in Zurich.

On May 26 Oliver Meier held a lecture on the future role of the EU and NATO in arms control at one of the events on the future of disarmament, jointly organized by the Friedrich Ebert Foundation and the Geneva Centre for Security Policy. At the seminar, attended primarily by Geneva diplomats, he argued that the EU needs a joint position in the current discussion of a nuclear-weapons-free world and that NATO must reform its nuclear weapons policy.

From studies to practice: The MPS Course visits Vienna

The seminar "International Organizations" took 22 students in the MA programme "Peace and Security Studies" (M.P.S.) and "Human Rights and Democratization" to Vienna from the 25th until 29th of May. Led by Prof. Götz Neuneck, head of the M.P.S. program, and Teodora Vrancean, an expert on Vienna and an M.P.S. graduate, the group visited several international organizations and some Austrian institutions to enhance their practical knowledge and approaches.

The group started the week by visiting the International Centre for Migration Policy Development (ICMPD), the Austrian Institute for International Affairs and the European Agency for Fundamental Rights and continued it by taking a look at several UN organisations the following day. While the International Atomic Energy Agency (IAEA), the United Nations Office on Drugs and Crime (UNODC), the United Nations Industrial Development Organization (UNIDO) and the German Mission to the UN provided insight into work practices as well as room for discussions, the presentation of the Preparatory Commission for the Comprehensive Nuclear Test-Ban Treaty-Organization was especially topical due to the North Korean test missile having being launched iust two days before.

Other opportunities for information, discussions and impressions were provided by the visits to the OPEC Fund for International Development (OFID), the German Mission to the OSCE, and the European Space Policy Institute (ESPI). Moreover, the day spent at the OSCE offered a wide variety of insights into OSCE's work. With lectures and discussions on the OSCE's crisis management and conflict prevention approach, the U.S. and Russian perspective on the OSCE, the OSCE's position on economic and environmental aspects of security, as well as the current EU Presidency's Mission the students were given the opportunity to talk to diplomats and practitioners alike. The group had the chance to follow the OSCE plenary for half a day. The excursion then was complemented by the return to academia with lectures in both the National Defence Academy on Euro-Iranian relations and in the University of Vienna's Department of Political Science.
