#### Peace Report 2008 presented in the Bundestag

In 2006 the world's 192 states spent USD 1,204 bn. on armed forces, armaments and military investments. In 2007 military expenditures amounted to USD 1,339 bn. and in 2008 they will increase again. The current massive arms build-up is comparable, in its volume and growth rate, to that of the Cold War. In view of the fact that an increase in military power is not likely to successfully handle the present and future threats to peace and international security, such development stands for a misallocation of economic resources and human energies.

This is the conclusion drawn by the Peace Report 2008, which was presented at the Federal Press Conference in Berlin on 3 June 2008. Representatives of the five editing institutes discussed the results and recommendations contained in the volume with the chairpersons of the Bundestag's Committe on Foreign Affairs (Ruprecht Polenz, CDU), Defence (Ulrike Merten, SPD) and Economic Cooperation and Development (Thilo Hoppe, The Greens), as well as with numerous Members of Parliament. A more extensive information meeting took place in the Federal Ministery for Economic Cooperation with State Secretary Erich Stather.

The authors see the tendency to military over-insurance, justified by real or imaginary enemies, as the main reason behind the current weapons boom. On the one side, emergent regional powers reject the hegemonic claims of unilaterally operating states and groups of states, but, on the other side, imitate such behaviour. Armament is supposed to strengthen the self-perception and external perception of a country's status. High economic growth in key regions and an easy access to military technology facilitate competition for military power, which, in turn, foments reciprocal mistrust, legitimates the comeback of violence as political instrument and fuels illusions about the impact of military problem-solving. The competition for military power is not stopped either by arms control measures or a vigilant public opinion.

The handover of presidential power in both Moscow and Washington may be a chance to revitalise international arms control policies. In the USA, the campaign for a nuclear weaponfree world supported by the group of authors around Henry Kissinger, which is being backed by an inscreasing number of influential personalities, gives reason to hope for a fundamental change in the prevailing security policy thinking. Germany, which abandoned nuclear weapons ambitions once and for all, is expected to strongly support this campaign. As for the role of the EU, the Peace Report recommends that a group of member states takes the initiative in the field of disarmament, according to the "core Europe" model, without waiting to reach an unanimous consensus among the 27 member states.

Most analyses included in the volume deal with the crucial present and future challenges in the field of arms control, like nuclear armament and non-proliferation, missile defence and the militarisation of space, conventional armed forces in Europe and the worldwide arms trade. The relationship between climate change and conflicts, as well as between authoritarian regimes and regional instability are also among the topics treated.

# German Foundation for Peace Research supports research on non-proliferation

The German Foundation for Peace Research will fund a project on the impact of technology transfers on efforts to control the spread of weapons of mass destruction. Götz Neuneck, head of the Interdisciplinary Research Group on Disarmament, Arms Control and Risk Technologies, will direct the project, while Oliver Meier will be the responsible researcher. Beginning in August 2008, the two-year project aims to analyse under which conditions measures to promote or control technology transfers strengthen the legitimacy of non-proliferation regimes. It will focus particularly on the impact of September 11, 2001 on the policies of industrialized, newly industrialising and developing countries. The project results will be discussed with decision-makers in various workshops and published in a book.

# 7th German-Chinese Security Dialogue

At the NATO Association in Geilenkirchen the group could learn more about the Airborne Warning and Control System (AWACS). # Change in the Middle East – Peaceful Solution or Escalation?

On 14 April 2008, Margret Johannsen participated in the Flensburg Dialogue organised by the Julius Leber Forum of the Friedrich Ebert Foundation. Knut Dethlefsen, Director of the Friedrich Ebert Foundation's Office in East Jerusalem, gave a speech on "Change in the Middle East – Peaceful Solution or Escalation?", and discussed the prospects of a negotiated settlement to the longstanding conflict between Israel and the Palestinians. He warned against developments that might undermine the two-state formula at the basis of a sustainable solution.

In the following discussion, Knut Dethlefsen and Margret Johannsen pointed to the lessons learned from other cases of constructive conflict transformation: in principle, dialogue between each party to a conflict should be possible and the exclusion of key players from negotiations would only lead to an impasse. In a third session, Dethlefsen and Johannsen took questions from the audience, many of which dealt with the role of international law in the Middle East conflict.
