# MPS 2007/2008 Graduation Ceremony - Ways to a durable peace and farewell to Hans-Joachim Gießmann

On 10 October 2008, during the graduation ceremony in the main building of the University of Hamburg, the students of the 6th academic year of the Master of Peace and Security Studies were conferred their degree. On the same occasion, the 27 students participating in the 7th edition were welcomed. The event also marked the formal farewell of Prof Hans-Joachim Gießmann, who directed the MPS programme in the past six editions. Since 1 October 2008 Prof Gießmann has been heading the Berghof Research Centre for Constructive Conflict Management in Berlin.

The president of the University of Hamburg, Prof Monika Auweter-Kurtz, confirmed in her speech the support of the University to the MPS programme. Dr Herlind Gundelach, senator for research of the City of Hamburg, referred to the need for top-level research and "a combination of fundamental principles and specialist knowledge" also in the field of peace and conflict studies, which can be effectively provided by the MPS programme. Like the other speakers, Senator Gundelach underlined the outstanding results achieved by Prof Gießmann.

Prof Volker Rittberger, director of the German Foundation for Peace Research, gave a lecture titled "Towards a durable peace? Peace research and its challenges at the beginning of the XXI century". Hans-Joachim Gießmann took stock of the outgoing class and its results, and, together with Patricia Schneider, the academic coordinator, handed over the Master's diploma. Prof Götz Neuneck, the new director of studies, wished the new students all the best for the coming year. To wish him good luck in his new role, Gießmann made him a symbolic gift: a magic wand. Denise Völker, held a speech on behalf of the new graduates, giving an account of the year in three different styles. The evening was accompanied by music played on guitar by Naida Mehmedbegovic.

Prof Michael Brzoska concluded the event expressing his thanks to Prof Gießmann for the excellent work at the IFSH as deputy director and, in particular, for the establishment of MPS as an accredited, well-demanded master's programme. MPS was founded on the initiative of Dieter S. Lutz, former director of the IFSH, but planned, implemented and further developed by Prof Gießmann since 2002.

Gießmann's merits were also made evident by the large number of participants, including many lecturers from partner institutes, as well as the numerous expressions of acknowledgement for his valuable work. As a leaving present he received a photo collage of all MPS graduates and a direction sign with the name of the IFSH, to show him the way back to Hamburg.

# Event at the IFSH on 26 November Freedom? Civil Society and NGOs in Russia, Ukraine and Belarus

Civil society free participation has a crucial role in shaping a country's public sphere: the more independent participation, the more self-determination. While in Russia not only politics, but also the civil society seem to be controlled by a "strong hand", Ukraine's civil society has experienced a relatively free development since the 2004 Orange Revolution, although the initial spirit of optimism has been now replaced by political chaos and disenchantment. As for Belarus, a country which is still extremely isolated from the West, not much is known about the internal situation and its local NGOs.

The condition of civil society in these three countries will be the focus of the event on 26 November at the IFSH. The speakers will be Jürgen Hufeland (first chairman of the German-Russian Society in Hamburg), Juri Durkot (journalist and interpreter from Lemberg/Ukraine) and Sascha Tamm (director of the division for Central, South-eastern and Eastern Europe of the Friedrich Naumann Foundation in Potsdam). The discussion will be moderated by Elena Kropatcheva, researcher at the IFSH, and Petra Beckmann-Schulz, political scientist and editor who lives in Hamburg.

## Gideon Levy and Catrin Ormestad Report from Occupied Palestine

The IFSH, in cooperation with the German Institute of Global and Area Studies (GIGA) and the Hamburg Society for Promotion of Democracy and International Law, has invited two outstanding journalists from Israel to present "Israeli Reports from Occupied Palestine". The event is generously sponsored by the Hamburg Foundation for the Promotion of Science and Culture.

Gideon Levy is a well-known Israeli journalist and peace activist who works for "Ha'aretz", one of Israel's leading newspapers. Mr Levy is one of the few journalists in Israel to focus on the occupation and its on-the-ground effects in Palestine. His colleague Catrin Ormestad is a Swedish journalist who has been living in Israel since 1993. Her work in the Gaza Strip has become immensely important, particularly since Israeli citizens – since the 2006 summer war in

Lebanon – have no longer been able to enter Gaza. Levy and Ormestad will present their findings at the GIGA Forum, and are ready to engage in a discussion with the audience afterwards. The forum will be moderated by Margret Johannsen and Martin Beck, Senior Research Fellows at IFSH and GIGA, respectively, who have been researching and teaching on the Arab-Israeli conflict for many years.

# **Workshop: Teaching Ethics and Peace to Science and Engineering Students**

From 15 to 17 October 2008, an international workshop titled "Teaching Ethics and Peace to Science and Engineering Students" took place at the University of Hamburg. The event was jointly organised by ZNF, IFSH and INES. 30 participants discussed how ethical aspects of peace and disarmament, sustainability and technological impact assessment can be integrated into university curricula in the context of the reform of European universities. The event was opened by, among others, Holger Fischer, vice president of the University of Hamburg, and Prof Cord Jakobeit, vice president of the Academy of Sciences. Prof David Holloway held the introductory lecture, which was also a prelude to the 2nd Carl Friedrich von Weizsäcker Forum on the Responsibility of Science. The renowned professor of history of science at Stanford University (California) talked about "Scientists, Politics and Peace During the Cold War". On 14 Oktober 2008, Götz Neuneck and David Holloway were involved in the organisation of a conference titled "Science, Peace and Politics: Is the Vision of a World Free of Nuclear Weapons Realistic?", which took place in the Magnus House in Berlin in the framework of a series of scientific events.

## **Tracing German Security Policy in Berlin**

From 9 to 12 October, the 2008/2009 MPS class participated in an excursion to Berlin dedicated to the topic "German Foreign Policy: Between Global Involvement and National Interests". The students completed a demanding programme of activities under the supervision of two junior officers of the Bundeswehr, as well as Patricia Schneider and Prof Götz Neuneck of the IFSH. On the first day, Dr Vag from the Federal Chancellery explained how the Chancellery and other federal ministries contribute to shaping Germany's foreign and security policy. The afternoon was spent in the Hamburg State Representative Office, where John Baumann, former director of the Political Department of the American Embassy in Germany, talked about the 2006 U.S. National Security Strategy, and gave an insider perspective on the difficulties of influencing a government's political decisions by political expertise. Friday morning was dedicated to Germany's security and defense policy. At the Bundeswehrverband, Ms Schattschneider presented the duties and political positions connected to the representation of soldiers. Afterwards, Ms Brüning, CDU member of the Bundestag, discussed the changing role of the Bundeswehr, and called for a new culture of honoring fallen German soldiers and the strengthening of foreign deployment of German forces. Friday afternoon, Stefan Bantle, consultant of the Foreign Ministry, gave an overview of his area of expertise, the Middle East conflict, and explained the importance of German diplomacy in the region. Saturday, after a visit to the Reichstag, the field trip ended with a guided bus tour of Berlin.

The several visits and discussions during the excursion made clear that the second pillar of Germany's foreign policy, after diplomacy, is the multifaceted engagement of the Bundeswehr.

The most disputed question was in what way cooperation can be continued, political damage limited and a new framework for co-operative security in Europe created against the background of the recent events in Georgia.

# IFAR<sup>2</sup> Lectures on Arms Control and Disarmament Visit to the former Semipalatinsk Test Site in Kazakhstan

On September 25, Oliver Meier spoke to the study group "Peace and Security" of the Federation of German Scientists on the US-India nuclear deal. The working group meeting was organized by its co-ordinator Götz Neuneck.

From 11 to 18 September, Oliver Meier participated as an observer in the on-site inspection exercise of the Provisional Technical Secretariat of the Comprehensive Test Ban Treaty Organization at the former Soviet nuclear test site in Semipalatinsk, Kazakhstan.

At the FONAS Annual meeting, which took place at the German Foundation for Peace Research in Osnabrück from 29 September to 9 October 2008, Götz Neuneck spoke about the Iranian Nuclear Programme and Hans-Christian Gils about simulations of missile defense trajectories.

From 16 to 18 September, the Center for Transformation together with the Institute for Political Science of the University of the German Federal Armed Forces organized a conference on "Space and Proliferation". The introductory session began with a lecture by Ambassador Peter Gottwaldt, High Commissioner for Disarmament, Nonproliferation and Arms Control of the Federal Government. This was followed by Götz Neuneck's report on the possibilities of a weaponization of outer space. Prof Neuneck also participated in the working group "International law and arms control".

On 13 September, Götz Neuneck participated in the well-attended IPPNW Congress "Culture of Peace" in the Urania in Berlin. He held a lecture on nuclear disarmament and missile defense, focusing on the connection between missile defense and nuclear deterrence.

## **CORE's Second International Central Asia Conference**

From 15 to 17 September 2008, CORE's second International Central Asia Conference "Cooperation with Central Asia - The Potential of the EU's Central Asia Strategy" took place in the Protestant Academy in Loccum. The event was organized by Anna Kreikemeyer and Wolfgang Zellner in co-operation with Corinna Hauswedell from the Loccum Academy. The conference combined the analysis of Central Asia's regional cooperation problems with a critical review of the implementation of the 2007 EU Strategy for Central Asia. Top-level political and academic experts discussed the potential for cooperation currently coming to the fore in the areas of education and science, including, for example, environmentally-oriented water management and intercultural and interreligious dialogue. A lessons learnt forum provided the opportunity to share information and exchange views on existing or completed cooperation projects with Central Asian partners. The conference organizers succeeded in bringing together more than 100 participants, including 32 panelists, among them twelve from the five Central Asian states. # **Conference: European Consortium for Political Research**

At the 2nd Graduate Conference of the European Consortium for Political Research, held at the Universitat Autinoma in Barcelona from 25 to 27August 2008, Sybille Reinke de Buitrago presented a paper entitled "The Impact of Psychological-Cultural Factors on Concepts of Fighting Terrorism: Learning Processes and Chances for Deescalation". The analysis of the American and the German approaches to the fight against terrorism focused on the psychological-cultural aspects underlying each country's strategy. The paper shows how the lessons learned in the past years and their peace potential are shaped and, at the same time, limited by those aspects. The conference offered a good overview of current research projects carried out by junior researchers in the area of political science in Europe, and thus reflected great diversity. The programme was completed by expert round tables and the opportunity for intensive exchange.

The German edition of the OSCE Yearbook 2007 will be published this autumn. Issues analysed in depth include the effects of the Kosovo status negotiations on Russian-EU relations and the *de facto* states in the post-Soviet space and the consequences of Russia's suspension of the CFE treaty. The special focus section on tolerance and non-discrimination includes contributions by Ambassador Dieter Boden, the Personal Representative of the OSCE Chairman-in-Office on Combating Intolerance and Discrimination against Muslims, Ömür Orhun, and the Secretary General of the OSCE, Marc Perrin de Brichambaut. All the texts included in that section have been made available by the OSCE's Office for Democratic Institutions and Human Rights via its TANDIS portal (http://tandis.odihr.pl).
